



**C**ampsite mas de la cam is situated in the outermost part of the National Park of the Cevennes. The property covers 62 hectares, is very calm, shady and quiet, bordered by the Gardon river, at some 3 kilometers from St. Jean du Gard. It is a beautiful area with plentiful hiking trails and biking routes.

#### Equipments

Pitches 80-150m<sup>2</sup>, 3 sanitary buildings, showers and washbasins with hot water, baby baths and toddlers' toilets, clothes washer and dryer, shop, bar, restaurant, take away, pizzas, TV, ice, gas, fridge-rental (6,00 € a day). The bar is open from 1 June until 9 September

#### Games

Heated swimming pool 500m<sup>2</sup> (trunks obligatory, no shorts allowed!) synthetic soccer field, volleyball, basketball, tennis (free

in the outer season), 2 pumtracks, table tennis tables, jeu-de-boules, playground, river, fishing, in the bar pool table, internet access en Wireless.

In July and August many sports' activities are organized and once a week live music at the bar. From 1 June (dates for each activity on demand) jeu-de-boules tournaments.

#### In the village

All shops, doctors, dentists, pharmacists, vet, busses to Nîmes and Alès, post office, bank, MTM, supermarket, every Tuesday market.

#### A few kilometers away

Cevennes museum, steam train from St. Jean du Gard to Anduze, Bamboo's park, Trabuc caves, Desert Museum, Silk Museum, horseback riding, golf practice at 30 km (course at 60 km)

#### Daytrips

The beach at 85 km, Gorges du Tarn and de l'Ardeche at one hour's drive, la Corniche des Cévennes, Mont Aigoual, Pont du Gard, Nîmes, Uzès, Avignon, la Camargue, la Provence...

#### Access

**Motorway A7**, exit Bollène, Pont St. Esprit, Bagnols-sur-Cèze, Alès, direction Montpellier, St.-Christol-lez-Alès, Anduze, St.-Jean-du-Gard, direction St.-André-de-Valborgne. The campsite is 3 km further on the left.

**Motorway A75**, exit Marvéjols, direction Florac, then St.-Jean-du-Gard via the "Corniche des Cévennes". At the T-crossroad, at the end of the Corniche, to the right, direction St.-André-de-Valborgne. The campsite is 500 m further on the left.

**O**n our campsite Mas de la Cam you can rent apartments (gîtes) which are situated in the former farmhouse at the entrance. The entire building has been renovated; the apartments are 27m<sup>2</sup> to 65m<sup>2</sup> big and can sleep four to six persons. Each apartment has a living room with kitchenette, a bathroom with shower and toilet, a couch that sleeps two, or in the larger apartments a bed for two.

Additional bedding is in bunk beds, sometimes in a small separate room (baby cots can be rented).

Blankets and pillows are present, sheets should be brought or can be rented (15€ per pers. per week). Next to each apartment you can sit outside, sometimes on a private terrace, or in a small garden.

Heating is possible in some gîtes and included in the price, these

can be rented from April until the end of September.

**Dogs are not allowed in the apartments.**

#### At your arrival

you will have to pay a deposit of 200€, cleaning fee (65 or 90€ depending of the size of the gîtes).

**The balance for rental accommodation is payable at the latest 30 days before the date of arrival.**

### General sales conditions

In order to become eligible to use the all services provided by mas de la cam, we request that you read the following general sales conditions carefully. These conditions govern the sale of holidays, and take effect from the moment the order is made. By reserving a holiday, you agree to comply fully with our general conditions.

#### ● Booking conditions

◦ The reservation becomes effective solely with the agreement of the camping, upon receipt of the deposit and either upon receipt of the booking contract duly completed and signed, or upon your agreeing to the general conditions of sale when booking on-line.

Booking of camping pitches or rented accommodation is made strictly on a personal basis. You may not under any circumstances sub-let or transfer your reservation without the prior consent of the camping. Minors must be accompanied by their parents or legal guardians.

#### ◦ Arrival and departure

· Concerning a camping pitch: arrival from 14.00 o'clock, departure between 7.00 and 12.00 o'clock. If departure takes place after 12.00 o'clock, another night will be added to your invoice.

Concerning rental accommodation: arrival Saturday from 16.00 o'clock – departure Saturday before 10.00 o'clock. At your arrival you have to remit a deposit of 200 euros; which will be rendered at the time of departure after subtractions of fees for cleaning, repair or replacement for any damages done to the accommodation or the premises.

#### ● Payment conditions

◦ For a camping pitch, at time of reservation a deposit of 30% of the total amount due + 18,00 € reservation fee. The balance must be paid in full upon arrival at the camp site.

.For rental accommodation, at time of reservation a deposit of 30% of the total amount due + 18,00 € reservation fee. The balance must be paid in full at the latest 30 days before the arrival date.

◦ For bookings made less than 30 days before the date of arrival, payment must be made in full at the time of booking.

#### ● Cancellation and alteration

◦ Alterations to your booking may be made at no cost before your arrival date, subject to availability and acceptance by mas de la cam.

• In the absence of any notification from you regarding a change of arrival date, the accommodation may be made available for sale again 24 hours after the arrival date specified on the contract, and you will consequently forfeit your booking. Any stay that is interrupted or cut short (late arrival, early departure) by you shall not give rise to reimbursement.

◦ In the event of cancellation by mas de la cam, except in the case of force majeure, the stay will be reimbursed in full. This cancellation shall nevertheless not incur the payment of damages and interest.

◦ In the event of cancellation less than 60 days before your scheduled arrival the balance is due anyway. A cancellation insurance is proposed to you.

In case of a cancellation before April 1st, 50% of the down payment will be refunded. After this date we will not give any refunds. We never give a refund for the reservations fee (18 euros).

No rebate is given for a late arrival, or for an early departure of our campsite: you will have to pay the entire amount of the period you've made the reservation for.

In case of the booking would be cancelled, all the deposits for the accommodation are kept back. In extreme case, we reserve the possibility to change the spot number of your renting.

#### ● Insurance

It is the camper's responsibility to take out insurance: mas de la cam accepts no responsibility in the event of theft, fire, bad weather, etc., or in the event of any incident concerning the civil responsibility of the camper.

All clients must comply with the provisions of the internal regulations. Each named tenant is responsible for disturbances and nuisance caused by persons staying with or visiting him.

#### ● Pets

Pets are not allowed in rental accommodation. At the camping site pets are allowed, apart from (French) category 1 and 2 dogs. All pets must be kept on lead at all times.

#### ● Most important points of the house rules

All our guest have to follow the house rules, which will be handed out to you upon arrival.

Your friends who like to stop by are welcome to do so, if they present themselves at the reception desk upon their arrival, remitting the fees due for their visit.

Each named tenant is responsible for disturbances and nuisance caused by persons staying with or visiting him. Visitors of customers are not allowed to use the pool.

Only gas or electrical (6 of 10 Amps) barbecues are allowed. The connection of electric cars in the accommodation of on your pitch is strictly prohibited.

### Data processing
